Texas Legal membership offers benefits across most areas of law:

Consumer law covers issues such as breach of contract, as well as civil action (defense), consumer protection, identity theft, creditors' rights and collections.

Criminal law covers a range of activities, including defense for DWI/DUI, juvenile court, misdemeanor, felony, insanity/infirmity and license suspension. Legal assistance for expunging/sealing records and habeas corpus is also available.

Family law encompasses matters such as adoption, divorce, custody and child support.

Estate planning focuses on wills, charitable planning and special needs planning.

Financial law pertains to areas such as foreclosures, tax law, real estate, loan agreements, social security/disability, Chapter 7 and Chapter 13 bankruptcy and financial counseling.

Additional legal issues covered by Texas Legal include document preparation, employment law, traffic tickets, landlord/tenant disputes, mediation and veteran's benefits.



Texas Legal provides new consultation benefit

Texas Legal has added a new consultation benefit that covers the cost of an initial meeting with a participating attorney. Consultations are brief meetings to discuss a potential or current legal issue, as well as coverage under your legal insurance policy. These meetings also offer the opportunity to determine if the participating attorney is a good fit for your particular situation. The consultation is limited to general legal discussions prior to any establishment of a participating attorney-client relationship. When you meet with your participating attorney, be sure to let them know that you are a member of Texas Legal and are seeking a consultation for your specific issue. The participating attorney will be responsible for contacting Texas Legal to verify that you are eligible to receive this coverage.

This benefit is available when your plan policy renews. See policy documents for limits and exclusions.

Supporting victims of identity theft

Texas Legal has partnered with AllClear ID, the technology leader in the identity protection market, to provide our members automatic access to identity repair services.

According to the FTC (Federal Trade Commission), there are more than 9 million victims of identity theft in the U.S. every year. That's about nine out of every 300 people, so there is a good chance you or someone you know has been affected or will be affected. There are various ways a thief can use your personal information, including misusing your Social Security number, making purchases with your lost or stolen credit cards, using your checking account or fraudulently opening an account in your name, among others.

If you experience identity theft, simply call the AllClear ID customer support team at 1-855-434-8075 and provide the coverage code "TXLID." From there, a licensed investigator goes to work on your behalf to restore your credit to its accurate state. No matter where or how the fraud occurs, the team is ready to assist.

Personal information is a valuable commodity. Knowing how to protect your information –and your identity – is a must in the 21st century and can help reduce your risk of identity theft. Texas Legal shares five tips on doing this effectively.



Keep your personal information secure offline.

When you order new checks, don't have them mailed to your home unless you have a secure mailbox with a lock. Destroy labels on prescription bottles before you throw them out.

Keep your personal information secure online.

If you post too much information about yourself on social media networking sites, an identity thief can find information about your life, use it to answer 'challenge' questions on your accounts, and get access to your bank accounts and other information.

Properly dispose of devices.

Before you dispose of a computer, use a wipe utility program to overwrite the entire hard drive. Before you dispose of a mobile device, check the service provider's website or device manufacturer's website on how to delete information permanently.

Safeguard your Social Security number.

Ask questions before deciding to share it, including if you can use a different kind of identification.

Keep your devices secure.

Don't use an automatic log-in feature that saves your username and password. Always log off your laptop when you are finished. Before you send personal information over your laptop, tablet or smart phone on a public wireless network, see if your information is protected. If you use an encrypted website, it protects only the information you send to and from that site. If you use a secure wireless network, all the information you send on that network is protected.

Adding dependents to your comprehensive coverage



Did you know that Texas Legal offers legal insurance for your entire family at a flat rate? The Family Coverage Option covers multiple dependents, and the premium for this option is the same regardless of the number of dependents you add to your policy.

Eligible dependents include spouses, domestic partners, children, stepchildren, legally adopted children, children for which you are the legal guardian, and grandchildren. An eligible dependent child must not be older than 26 to receive coverage.

Changes received between the 1st and the 25th of each month are effective on the 1st of the following month. Changes received between the 26th and 31st of the month are effective on the 1st of the month after the following month. (For example, if received on March 26th, changes are effective May 1st.)
